HOME SCHOOL REGISTRATION 2023-24

Dear Parents/Guardians:

Our records indicate that you either home schooled your child(ren) this past school year or requested home school information for the 2023-2024 school year. To assist us in meeting the legal reporting requirements, we ask that you review the information that is available on our district website www.farmington.k12.mn.us. If you are unable to access this information, please contact me to receive the forms you would like. Due to changes in home school legislation, please find the appropriate instructions below.

Minnesota Statutes 120A.22-120A.26 and 121A.15 requires the person in charge of providing instruction to a child must submit the following information to the superintendent of the district in which the child resides:

- 1. by October 1 of each school year, any current home schools that are reenrolling students will need to submit one of the following:
 - a. Minnesota Home School Full Report; or
 - b. A Letter of Intent to Continue Home Schooling, which must include any changes to last year's information.
- 2. By October 1 of each school year, if you are a new home school or enrolling new students, you will need to submit all of the following:
 - a. Minnesota Home School Full Report
 - b. Documentation of immunizations

Special Education Services

State and federal laws require every school district to locate and offer special education and related services to students, public and private, who are eligible under the guidelines of the state. In Minnesota, homeschools are considered nonpublic schools.

Farmington Area Public Schools work with nonpublic schools to find students, starting at birth, who may need special education services. This is called "child find" and is required by state and federal law. To determine if a student is in need of special education and related services, a comprehensive evaluation must be conducted by the school district special education team. This initial evaluation is typically completed on site of the public school by a certified special education evaluation team.

If students enrolled and attending a homeschool meet criteria and are in need of services, the district team will work together with the family to propose an individual education or service plan. The majority of the time, services are offered on site of the public school.

Farmington Area Public Schools provide specially designed instruction and programming for students with special learning needs. We pride ourselves on the quality of our staff and our efforts to provide appropriate instruction for each student based on the latest education research. We are committed to developing the skills and potential of every student serviced.

If you are concerned about your child's educational achievement, language, articulation, hearing, vision or social/emotional development and you suspect that your child may have a disability, please contact Ms. Dana Strop at 651-463-5020.

If you decide to enroll your child/children in Farmington Area Public Schools or another non-public school instead of home school for the 2023-24 school year, please let us know. EDUCATIONAL AID REIMBURSEMENT RATES:

The Minnesota Department of Education has established the following authorized rates of entitlement per eligible pupil to be used in computing district allotments for non-pupil aids for school year 2023-2024 as follows:

Pupil Health Services\$	85.30
Secondary Pupil Guidance & Counseling Services\$	317.11
